Chugai Pharma Manufacturing to Conclude an Agreement with Fujieda City to Offer Help During Times of Disaster

November 28, 2012 - Chugai Pharma Manufacturing Co., Ltd. (“CPMC”) [Head office: Kita-ku, Tokyo; President: Hisayuki Takahata], a wholly-owned subsidiary of Chugai Pharmaceutical Co., Ltd. (“Chugai”) [Head Office: Chuo-ku, Tokyo; Chairman and CEO: Osamu Nagayama], announced today that it will conclude an agreement with Fujieda City, Shizuoka Prefecture (Mayor: Shohei Kitamura), in order to cooperate during times of disaster by providing places for temporary evacuation shelter and assisting recovery activities. The agreement outlines the cooperative measures to be taken in the event of large-scale natural disasters such as earthquakes, as well as other equivalent emergency situations.

Since its establishment in 1971, CPMC’s Fujieda Plant has maintained collaborative relationships with the people of the region while carrying out business activities. To play an active role in securing the safety of the local community, CPMC has decided to cooperate with the disaster management plan set forth by Fujieda City.

Under the agreement, CPMC will offer part of the second floor of the solid-form drug building of its Fujieda Plant to the residents of Fujieda City and neighboring districts as a temporary evacuation shelter, upon request by Fujieda City. Also, CPMC will offer food, water and daily items enough to accommodate 100 residents overnight at the temporary evacuation site, free of charge. Vacant spaces on the premises of the Fujieda Plant, such as the playing field, will also be offered as a place for carrying out disaster recovery activities.

As the responsibility of a company whose business is related to human life, Chugai Group is committed to ensure stable supply of drugs even in the event of earthquake disaster, and proactively cooperate with regional communities as part of its social contribution activities. Chugai Group sincerely hopes that this agreement proves to be useful in the disaster management efforts of people living in Fujieda City and the vicinity of our plant. Chugai Group will continue to collaborate with the local residents.
