Transfer and Future Marketing of Anti-Cancer Agent “Tarceva[®] Tablets 25, 100 and 150” in Japan

TOKYO, January 14, 2025 -- [Chugai Pharmaceutical Co., Ltd.](#) (TOKYO: 4519) (hereafter, Chugai) and [CHEPLAPHARM K.K.](#) (Japanese-only website) (hereafter, Cheplapharm) announced that Chugai will transfer the business in Japan concerning the anti-cancer agent “Tarceva[®] Tablets 25, 100, and 150” (hereafter, Tarceva) to Cheplapharm. Chugai in-licensed Tarceva from Roche and is the marketing authorization holder in Japan.

Chugai has been marketing Tarceva and providing information in Japan since 2007. In consideration of the maturity of the product lifecycle, Chugai, Roche, and CHEPLAPHARM group revisited the marketing of Tarceva in Japan and concluded that CHEPLAPHARM group should solely market Tarceva after transferring assets related to Tarceva that are owned by Roche and Chugai, including the marketing authorization and intellectual property rights (patents and trademarks, etc.), to CHEPLAPHARM group.

Cheplapharm and Chugai are proceeding with the necessary administrative and legal procedures for the completion of the transaction. The transfer of the marketing authorization is scheduled to take place on April 1, 2025, and the sales transfer is scheduled to take place in June 2025. Cheplapharm will be solely responsible for the marketing and information provision activities for Tarceva in Japan thereafter.

Cheplapharm and Chugai will cooperate to ensure a stable supply and achieve a smooth transfer of the marketing authorization regarding Tarceva.
